Open Access: For authors who wish to publish manuscripts under Open Access, an open access fee of \$1,000 is required in addition to the page charges outlined above. Open access articles will become freely available to the public through HighWire Press at the time the journal issue containing the open access article is posted by HighWire. The author(s) submitting open access articles shall bear sole responsibility for meeting specific posting requirements of their funders.
